In line with statutory Health and Safety Legislation, Poole's Cavern has carried out a risk assessment for schools /groups visiting the site.

In the tables below we have set out potential hazards and how, with the assistance of leaders, we intend to reduce those risks.

Feeling Unwell.	First aid equipment on site. Group leader should escort ill person from cave with direction from the cavern guide.	LOW
Hitting Head.	Extra illumination & verbal warnings in narrower/lower passages. All Incidents reported, leading to any necessary procedural review.	LOW

Emergency Evacuation.	Staff trained in evacuation procedure. Time of entry & number in cave recorded.	LOW
Loss of Lighting.	Automatic emergency system. Guide always carries torch	LOW
Rock-fall.	Daily safety check. Regular geological inspection.	LOW
Leaving Cave.	Pupils not to leave without adult accompaniment. Head warning.	rom
Rain fall/adverse weather	The underground stream does not reach the level of the path even in heavy rain. The cavern is safe to enter in any weather condition	LOW

Merchandise.	All goods satisfy regulatory safety standards. School/Group leaders asked to supervise children when in retail areas. Limit numbers to 10 max at a time.	LOW
TOILETS:	Slips & Trips. Cleaned and maintained on a daily basis. School/Group leaders asked to supervise children using facilities. Regular checks by staff.	LOW
CAFE	Café is for customers consuming items purchased on site only.	LOW

WOODLANDS / KIDS ACTIVITIES:		
Slips & Trips.	Regular maintenance. Schools/Groups using the Woodland area do so unsupervised by Poole's Cavern staff.	LOW
Woodland activities	Assess weather conditions, wind and rain may affect safe access to woodlands	Assess on site conditions and liaise with Poole's Cavern staff
GO APE COURSE	Groups should not attempt to access any High Wire course installations or equipment or in any way interfere with staff or participants on the GO APE course.	HIGH
Play area	Children should be supervised whilst using the play area	LOW
Picnic Area	Children should be supervised at all times. Litter should be collected and placed in bins provided. Extra bags provided on request.	LOW
Schools room	Fire alarmed and emergency exits illuminated. Groups should be supervised at all times whilst using this facility	LOW
